## MILESTONE RECIPIENT OF ILLINOIS CHILDREN'S HEALTHCARE FOUNDATION GRANT

ilestone, Inc. is the recipient of a \$262,000 grant from the Illinois Children's Healthcare Foundation (ILCHF) which will be used to help expand the existing dental clinic to deliver pediatric dental care to children with developmental disabilities across Northern Illinois.

He's In Good Hands

The ILCHF received nearly 300 Letters of Inquiry from across the state in June of 2004. Fifty of those were then invited to submit a full proposal. The full proposals were reviewed by the ILCHF Board and a group of outside advisors. The announcement came on December 6, 2004 with 32 organizations from around Illinois sharing

\$6,000,000 in grant funds from the Foundation.

Improving the oral health of Illinois children was one of the four areas that the Foundation identified as an area of greatest need. It was under this initiative that the Milestone Dental Clinic was deemed worthy of the grant award. The awarding

of this first cycle of grant dollars marks the first contribution of funds from the ILCHF, which was created in 2002. The funding is a result of a 125 million dollar settlement made between former State of Illinois Attorney General Jim Ryan and an Illinois insurance carrier. ILCHF Chairman C. William Pollard said, "As we complete this first grant cycle, we are grateful for the foresight of Jim Ryan, who as Attorney General, initiated the formation of the Foundation". Former Rockford Mayor, Charles Box, is also a member of the Foundation Board.

Expansion of the dental clinic is currently in progress. The expansion includes the addition of three dental operatories and a larger reception area. It is projected that construction will be complete by April 15th. Milestone, Inc. is currently working on securing operating funds for an additional full time dentist, full time

hygienist, two full time dental assistants, and a part time clerical position. The ILCHF's next grant cycle begins in June of 2005, with awards in December of 2005. A grant will again be submitted to the Foundation for operating funds.

## ONE MAN'S JOURNEY LAUGHING ALL THE WAY....

ohn Gregg is a 54-year-old man with an extraordinary sense of humor and an uncanny ability to bring laughter to all around him. On August 18, 1951, John Gregg was the first born of John Andrew and Mary Gregg of Rockford, Illinois. Mary recalls that there was something different about John when she took him home, but the doctor who delivered John provided the Greggs with little information. Months later, Mary and John realized that their son's developmental growth seemed to be impeded. They sought consultation from another physician. It was at this time that they learned that their son had been born with Down Syndrome and would always be developmentally delayed. The doctor recommended that their son John be sent to an institution for the mentally retarded. Unfortunately, in the 50's, that was the course of treatment recommended by most physicians.



John At Home

Loving parents, John and Mary, followed the doctor's orders and on November 6, 1952 John was placed at Dixon State School in Dixon, Illinois. The family visited often and were as involved as a family could be in the care of their son, but the distance from Rockford made frequent visits difficult. At the same time, they were raising additional children – a daughter, Pam, and a son, Brent. This made the visits to Dixon even more difficult. Nineteen years later, John was transferred from Dixon to Elgin Mental Health Center in Elgin. Illinois. He remained

there until 1974 when he was transferred to Shapiro Development Center in Kankakee, Illinois. All along, the family visited frequently.

One day in 1980, Mary Gregg was at the Hilander grocery store in Rockford where she met a friend, Audrey Wickstrand. Audrey recommended that John and Mary consider moving their son to Milestone's Elmwood Heights. Elmwood Heights had opened in September of 1979. The purpose of this home was to help Rockford bring its disabled sons and daughters back home to Rockford. Mary and John immediately applied for their son's transfer and on May 14, 1980, John's journey landed him back in Rockford at Elmwood Heights. For the Greggs, this meant no more long trips to visit John, and as importantly, now they had the ability to take him home, to have him stay for dinner, to play with their dog in the backyard, and to be a part of their family again.

For the next 18 years, John and Mary Gregg became volunteers extra ordinaire with Milestone. They assisted with every fashion show, every poinsettia sale, and every other event held by Milestone because John and Mary and their son, John, had joined the Milestone family. Mr. Gregg died in 1998, but Mary continues to this day an integral part of the Milestone family.

For John, life's journev has had its trials and tribulations. John now lives at Milestone's Searles Group Home. His unique personality is unforgettable. John is a jokester. He uses his sense of humor to give others laughter and happiness. He loves sticking his tongue out at others, which is always followed by a hearty laugh. This is his trademark. He will greet you with a wink and a smile and, while at times he can be challeng-

ing, John's personality and wit always save the day.

In 1999, John had major spinal surgery to correct cervical instabilities. Following the surgery, John had to wear a halo for two months in order to keep his spine in proper alignment. Through this entire ordeal, as painful and uncomfortable as it must have been, his humor, his laughter, his wonderful smile remained the centerpiece of his life. John is now 53 years old and while his journey continues, the last 25 years being home in Rockford has meant so much to his mother, the staff at Milestone, and his friends, the individuals served at Milestone. As his journey continues, laughter and smiles will accompany him and all of us who have the opportunity to share his life with him.

## FAMILY/GUARDIAN SATISFACTION SURVEY RESULTS FOR 2004

ilestone annually surveys its families and guardians in an effort to determine their satisfaction with our services and to enlist their recommendations for improvement. The 2004 survey results are as follows.

Milestone received an overall satisfaction rate of 99.2% and had a survey return rate of 82% for adult services. This compares with a 99.5% satisfaction rate in 2003 and a 78% return rate. For 2002, our satisfaction rate was 99%, with a survey return rate of 54%.

Milestone was pleased with the satisfaction rate, but was even more appreciative of the increase in surveys returned. This means that Milestone is continuing to strive for improved communication with its families and guardians, and that its efforts have been successful.

The results of the survey show that Milestone's strengths consist of the care and services we provide to the individuals, the quality of their living environments, and the accuracy of the information we provide. Areas in which the families and guardians requested improvement were the families' participation in the design of the services provided and improved communication with the families and guardians.

For the RocVale Children's Home, the overall satisfaction rate was 97%, with a 53.1% return rate. This compares in 2003 with a 84.5% satisfaction rate and a survey return rate of 30%. Milestone needs to continue to strive to increase the return rate for our children's facility.

These survey results are distributed agencywide to our staff, Board of Directors, and also are sent to our families, guardians, and funding and regulatory agencies. The information gained is used to evaluate Milestone's strengths and weaknesses and to develop plans for improvement.

Thanks to all family members who participated in this survey. The more information Milestone receives, the better we can serve your family member. Family members should not wait until the next

survey to express a complaint, recommendation, area of improvement or to provide a compliment. We request this information all year round. ## THREE-YEAR NATIONAL ACCREDITATION AWARDED BY CARE
