#### **HUMAN RIGHTS COMMITTEE**

The Human Rights Committees at MILESTONE and RocVale Childen's Home, ensure the rights of our individual's are protected along with promoting dignity in treatment. The two committees are being merged into one committee representing the entire agency.

The committee is a forum, designed to resolve concerns regarding care and/or approval of therapeutic treatments as presented by parents/guardians, conservators, individuals and staff. The committee is composed of members of the community, guardians of individuals from our programs, and staff from MILESTONE and RocVale. Fifty percent of the committee must be community representatives.

The committee also assists individuals and their advocates, in understanding and exercising their rights, as defined by law. It can also make recommendations to Jim Hamilton, the Chief Executive Officer, regarding procedures for ensuring individual rights, the resolution of rights issues, and addresses issues presented by the CEO, Senior Vice Presidents, Administrators of all programs, and Individual Services/Program Directors.

All matters are confidential. All individual's records and information regarding Human Rights issues is confidential and may not be reviewed by staff of MILESTONE, Inc. or RocVale Children's Home without first gaining consent of the individual and guardian.

# MILESTONE DENTAL CLINIC RECEIVES GRANT FROM DELTA DENTAL

Tim Woods and Lynne Williams from Delta Dental presented MILESTONE President and CEO Jim Hamilton and MILESTONE Dental Clinic Administrator Kathy Olson a check as part of a



grant to help the Dental Clinic expand its service area and provide services to more special needs patients. The MILESTONE Dental Clinic is the only free standing clinic in the nation designed to serve only the Developmentally Disabled population.

#### **ASK A DENTIST** From the Desk of Dr. Jason Grinter:



Cancer can affect any part of the oral cavity, including the lips, tongue, mouth and throat. The American Cancer Society estimates that there will be 35,310 new cases of oral cancer diagnosed in 2008. One American dies every hour from oral cancer. The most common symptoms are:

A lump or thickening in the cheek

A white or red patch on the gums, tongue, tonsils or lining of the mouth

A sore throat or feeling of something caught in the throat

Difficulties in chewing, swallowing, or moving the tongue or jaw.

All of the symptoms have other causes as well. But, if you experience any of these symptoms lasting more than 2 weeks you should see a doctor or dentist. The biggest risk factors for oral cancers are gender, age, smoking and alcohol consumption. Oral cancer is twice as common in men, and half of all oral cancers are diagnosed in people over 68. 90% of patients with oral cancer use tobacco. Oral cancers detected in the early stages have a much higher survival rate. If you are a person with high risk factors for oral cancer you should check your mouth monthly for the symptoms.
