EVERYONE IS ALL SMILES AT ROCVALE'S SENSORY FIELD DAY

The children at RocVale had a wonderful time during the Annual Sensory Field Day. Most of the children have a form of autism, and sensory integration/stimulation is one form of behavior modification therapy that reduces each child's maladaptive behaviors while having fun. The day was filled with objects and activities designed to strengthen sensory integration for each child. This is a form of therapy in which specific exercises are designed to enhance each of the senses. There was a sensory pool filled with edible objects, activities with bubbles, water balloons, sidewalk chalk and paint, bean bags, and texture



materials. These activities also allow the children to enhance their communication and social skills and develop habits













that will carry them into adulthood. But the highlight of the day was a visit from the Ice Cream Truck. All of this was made possible thanks to a Hometown grant from the General Mills Foundation.

EVERYONE IN THE FAMILY LENDS A HELPING HAND



Every year Leslie Emerson's grandchildren count the days until they can travel to Illinois from Texas to see their Grandmother, but also to staff a lemonade stand to raise money to help the organization where their Uncle Doug lives. Each year they help make the lemonade, and lemon cookies, decorate the table that will hold the goodies and ask people for donations while they share the story of their Uncle. The children keep nothing for themselves and insist that all the money donated go to MILESTONE.



Their Uncle Doug lives in one of MILESTONE's Adult Group Homes. His journey is unique in that he lived at home with his mom until he was in his 40's. His family knew that placement in a residential facility would be needed at some point, but they also knew it would be

an easier transition for Doug if it happened when there was not a family emergency. Soon after they started the process his mother was notified there was an opening at MILESTONE. Doug's mother, Myra Schmitt, eased him into the transition by saying he would be able to go more places and make new friends. Not only did Doug move into a new home,



he also started working at a new place, MILESTONE Industries. His mother says she has seen Doug blossom, and while he likes to come home to visit he is always ready to return to his place and his friends. Since moving to MILESTONE he attended camp for the first time, and loves the MILESTONE program at Camp

Winnebago. He enjoys going out to eat with his housemates and to baseball and basketball games. Schmitt says the staff at his home do an outstanding job of planning activities for the guys living there. Doug also still loves attending Festa Italiana each year with mother and other members of his family.

She also knows that members of MILESTONE's staff will inform her if Doug needs anything or if there is an issue. She says they treat Doug like he is a member of their family and knows exactly what he needs and when he needs it.

While Doug's transition went smoothly, Schmitt advises other parents to start planning early, and get on a waiting list so you do not need to make decisions during an emergency. Adding the best thing you can do for your adult child is plan for their future starting at an early age.


